- 4. Discussion of Action Items:
 - Green Energy Grant June McNeil read an email from Michael Bussell stating that he spoke to Jim
 Hubert and the grant application period is in April. David Amari said Ecosystems would like to
 meet to discuss geothermal options. David Amari is to schedule a meeting the following week
 with Ecosystems representatives, Brad Morgan, Nancy Haines, Jim Hubert, and Michael Bussell.
 He will ask if state contracts or MHEC contracts apply.
 - Abatement Reports/Quotes David Amari is working on obtaining quotes from the Abatement Management team for the tunnels.
 - Stair Tread Height Adjustment David Amari said one step is 8" and needs to be 7". All eight steps from the top step to the first landing will need risers adjusted so that they are all the same height. It will be very close to make them all within 7". He will clear the exact specifications through the Ashby building inspector. This project will need a licensed contractor to complete.
 - Gym Roof Drain Repair David Amari is contacting roofing companies for quotes.
 - New Chair Lift Nancy Haines will request bids.
 - Old Wing David Amari noted the items that need to be addressed are boards for the windows, roof leaks, a fan for ventilation, and sealing the door. He will begin sourcing quotes for materials.
