Priority 5: Replacement, renovation, or modernization of school facility systems, such as roofs, windows, boilers, heating, and ventilation systems, to increase energy conservation and decrease energy-related costs in a school facility.

Priority 7: Replacement of or addition to obsolete buildings in order to provide for a full range of programs consistent with state and approved local requirements.

  - Superintendent Morgan said he was working with the Public Relations firm to draft an educational press release for the community.
  - The Committee talked about the approved budget and contingencies.
  - Ms. McNeil said the district should lower the budget and return the contingency monies to the towns.
  - Mr. Morgan did not recommend lowering the budget. He said contingency funds might be needed for staffing.

Following discussion, Randee Rusch moved, and June McNeil seconded the School Committee adopt an FY2024 operational budget of \$56,360,939.00, an FY2024 transportation budget of \$4,086,799.00, an FY2024 Debt service budget of \$4,241,313.00 and to use these funds to calculate the Fy2024 school assessments for member towns as required by statute. In addition, the Committee authorizes the use of \$2,045,000.00 from the Excess and Deficiency Account to offset the FY2024 operational budget.
