#### 3. Discussion of Action Items:

- Oil Tank David Amari received the Scope of Operations from the engineer, and permits are being finalized. The estimated removal is at the end of July.
- Green Energy Grant Ecosystems sent a Scope of Project, which David Amari will forward to the
  full committee before the next meeting. Ecosystems do not consider it an energy project as much
  as a capital project. David Amari is also working with Rise Engineering. Mr.Dimario, the engineer
  from Rise, and Frank Davey, the grant specialist from Rise, are working on a proposal. Pourier &
  Springer will also evaluate our boiler system to explore all options. Nancy Haines stated the grant
  request needs to be submitted by October 20.
- Abatement Reports/Quotes David Amari said he is meeting with Vinnie from Turner Consulting within the week. He expects to have quotes before our next meeting.
- Stair Tread Height Adjustment David Amari said two contractors have expressed that measurements will be very close to code. He is reaching out to Mike Savageau and Scott Hobart to try to come up with a solution.
- Gym Roof Drain Repair David Amari is awaiting quotes.
- New Chair Lift David Amari said the technician will be out in a week to evaluate any needed repairs, but the chair lift is still compliant. Dawn Roy noted that if an adjustment were required to the stair height, we would have to ensure the chair lift was not impacted.
- Old Wing David Amari stated that the fan was installed, and the doors were sealed. He received
  two quotes for boarding the windows and will proceed with the best fit according to the district's
  standard process.
- Ramp/walkway rail David Nadeau will follow up with Mike Savageau on the compliance letter.
- 4. Discussion of Multi-year Plan: David Amari noted the draft plan may need updating once abatement quotes come in and decisions are made on the heating system. He also noted some projects may be removed/changed. He stated that with the heavy rains this summer, there have been issues with the storm drains. Michael Bussell has arranged to fix the sinking drains in the parking lot. Once those are repaired, the drains causing flooding by the air handlers can be unsealed.

- 6. Other business Ann Cromwell-Gapp stated that AES purchased portable bleachers with funds previously fundraised years ago. She inquired about the removal of the current bleachers. June McNeil asked if the town or district owns the bleachers. Nancy Haines said she would look into it.
